

- A police officer helps a woman look for her missing child.
- Police: Hello. Huangdu Police Station. What can I do for you?
- Woman: (Crying) Help! Help!
- Police: Don't panic, madam. Tell me slowly, what has happened?
- Woman: My daughter ... my daughter is missing.
- Police: Okay, calm down, please. Where are you? And how did it happen?
- Woman: In Tian'an plaza. We were shopping in the cosmetics section on the ground floor. I turned around and she was gone.
- Police: How long has your daughter been missing?
- Woman: About half an hour. I've been looking for her everywhere.
- Police: Can you give us some details about your daughter?

- Woman: Her name is Monica. She's five years old. As for her ... her height ... her height, about one meter. She has beautiful long black hair, a bit curly . She's skinny and small for her age. And she's wearing ... wearing ...

现在完成进行时

I've been looking for her everywhere.

我已经到处在找她了。

构成为: 主语+助动词(have / has) + been + 动词的现在分词+其他成分

现在完成进行时,表示动作或状态从过去某一时间开始,一直持续到现在,或者刚刚终止,或者可能仍然要继续下去;也可以用来表示某种经历。与since,for连用时,常常表示动作会进行下去。例如:

I have been learning English since three years ago.

They have been living in this city for ten years.

- Trademark Infringement
- A client seeks legal advice for a trademark infringement case.
- Lawyer: Based on what you've told me so far, it sounds like your competitor is infringing on your trademark.
- Client: Exactly. And the potential damage to my business is huge. What legal action can we take?
- Lawyer: Well, there are several things we can do. First, we can file an action in the district court and move for an injunction against your competitor. We need to show the probable harm to your business.
- Client: I'm sure they'll challenge that. They won't confess to the claim.

- Lawyer: Right. Actually, "confess" is used in criminal case. In civil case we say "admit the claim".
- Client: Oh, I see. A slip of the tongue.
- Lawyer: We'll also be seeking declaratory relief and damages for any losses you've suffered.
- Client: I know what damages are, but what's declaratory relief?
- Lawyer: It's a declaration by the court that you are the rightful owner of the trademark. As for damages, if we're going to be able to recover your losses we'll first have to prove them. I'd like my team to meet with your people to start gathering evidence.
- Client: That's fine as soon as possible.

将来进行时

We'll also be seeking declaratory relief and damages for any losses you've suffered. 我们也会为你所遭受的任何损失争取确认赔偿请求。

• 将来进行时主要表示将来某一时间正在进行的动作,或表示要在将来某一时间开始,并继续下去的动作。一般用延续性动词表示。例如:

This time next day they will be sitting in the cinema.

• 将来进行时常用的时间状语有soon, this evening, on Sunday, by this time tomorrow, in two days, tomorrow evening 等。例如:

By this time tomorrow, I'll be lying on the beach.

Please come tomorrow afternoon. I'll be having a meeting tomorrow morning.

Pedestrian Critically Injured in Westwood Hit-and-Run Crash

- A pedestrian was critically injured in a Westwood area car accident near the corner of Wilshire Boulevard and Veteran Avenue early morning on January 5, 2016.
- The police said it involved a hit-and-run driver. The car was dark and was last seen traveling east on Ashton Avenue from Veteran Avenue. The investigation is ongoing.

- It appears that the driver struck and seriously injured the pedestrian, and left the victim lying in the roadway without even stopping to help or call emergency personnel. Outrageous! Leaving the scene of an injury or fatal crash is a serious crime under California law. California Vehicle Code 20001 (a) states: "The driver of a vehicle involved in an accident resulting in injury to a person, other than himself or herself, or in the death of a person shall immediately stop the vehicle at the scene of the accident."
- We hope the driver in this case is arrested and brought to justice. If you have any information about the suspect or the vehicle, please visit the Hit-and-Run Reward website at hitandrunreward.com to offer a useful tip and become qualified for a \$1,000 reward.

How to Report an Accident?

• A car accident can happen when you least expect it. You could be switching lanes , looking for a parking space or pulling out of your driveway , and all of a sudden, crash! Whether you hit someone or another driver hits you, you need to know what to do after a car accident. Here's a checklist to keep in mind when it comes to reporting your car accident.

- 1. Take down the other driver's license plate number as well as the make, color and model of the vehicle. If there is no pen and paper available, repeat the numbers in your head until you can write them down or snap a picture with your mobile phone.
- 2. Call the police. Police will be needed on scene to direct traffic and to help get all vehicles to safety. Also, a police report is needed for the insurance company to determine who is responsible for paying the damages.
- 3.Check for injuries to yourself and to your passengers before getting out of the car. Never step out of the car into moving traffic.

- 4. Look for witnesses. Politely ask the witnesses (if any) to wait with you until the police come so that they can give their statements about the crash.
- 5. Exchange contact information with the other driver for insurance and payment issues.
- 6. Report the accident to your insurance company just in case you may need to file a claim.
- And a final note: protecting your safety is the first priority after a car accident. Turn on your hazard lights as soon as possible and put up other signals behind the crash scene so that other drivers should proceed carefully and safely.
